#### **Background**

Public-Private Partnerships (PPPs) can serve not only as a mechanism for attracting private investment but also as a tool to accelerate the achievement of the Sustainable Development Goals (SDGs) at the national level by mobilizing funds into sustainable infrastructure development.

The UNECE has developed the concept of PPPs for SDGs which is designed to implement the SDGs by putting people's interest and sustainability at the core of infrastructure projects.

The event will be an opportunity for government officials, local practitioners, and other local stakeholders alongside the donors and International Financial Institutions (IFIs) that are working in Armenia, to better understand the UNECE approach to PPPs for the SDGs in designing and implementing PPPs to support the efforts of Armenia to achieve the SDGs.

## Objectives and expected outcomes

The main objectives of the event are to:

- 1. help the participants gain knowledge and understanding of the UNECE approach to PPPs for SDGs.
- 2. present and discuss recent legislative developments in the sphere of PPPs in the Republic of Armenia and how UNECE PPP tools, standards and guidelines can be used for further policy and legislative improvements, and
- 3. help the participants gain knowledge and understanding on how to prepare and implement PPP projects aligned with the SDGs.
